5. The work shall be completed within 10 days from the date of award of the work.
6. The labour engaged and working equipment brought by the contractor for the work shall be recorded in the NIN Security Gate before entering into the premises and obtain necessary gate pass.
7. Payment will be made against the bill along with a statement of measurement taken in the presence of the contractor and the civil engineer of NIN, Hyderabad.
